## PART A

- 1. A 7-year-old male child living in a foster home was admitted to the casualty ward with a history of fall and limping of the right lower limb. X-ray examination revealed a fracture in the lower limb and based on the fracture pattern treating doctor suspected possible maltreatment of the child.
  - 1.1.Briefly describe the type of long bone injuries that are resulted from child maltreatment. (20 marks)
  - 1.2.List the possible pathological conditions that can be considered as a differential diagnosis in suspected bone fractures in children. (10 marks)
  - 1.3.List five important points in history that can give suspicion about a physical child maltreatment. (10 marks)
  - 1.4.Briefly discuss three injury patterns in the skin that can be caused by physical child-maltreatment. (15 marks)
  - 1.5. During the history-taking child revealed a history of possible chronic sexual (anal) abuse. Briefly discuss the examination findings in chronic anal penetration (20 marks)

6.As a part of the management of this child, a case conference was arranged by the judicial medical officer. List the members usually take part in a case conference of a diagnosed child abuse.

- 1.7.Briefly discuss important points that are usually discussed in case conferences in diagnosed child abuse. (15 marks)
- 2. A 23-year-old girl was found dead in an abandoned building. A nylon rope was found around the neck and her clothing was disturbed. She was last seen with her boyfriend at a night party on the previous day.
  - 2.1. List the medico-legal issues in this case

He was observed and managed conservatively in neurosurgical unit and discharged on the third day.
